She eventually learned to drive. Her grandparents inspired her and encouraged her to live life to the fullest. Their support gave her the courage and understanding, that she could do anything she set her mind to and that was the life Ginny lived. She was a member of the St. Paul's United Methodist Church in Celina.
